### Executive Summary

This Info-Flash notifies Members of the halted trading on the LIFFE CONNECT® for Equities Trading Engine that supports the Amsterdam, Brussels and Paris Individual Equity Options and Amsterdam Currency Contracts on 8<sup>th</sup> of August.

At 10.11 am (CET) trading was halted on the LIFFE CONNECT® for Equities Trading Engine that supports the Amsterdam, Brussels and Paris Individual Equity Options and Amsterdam Currency Contracts. The application was restarted and put into session start at 10.29am (CET). Following a pre-open period, trading was resumed in Brussels and Paris Contracts at 10.55am (CET) and Amsterdam Contracts at 11.00am (CET).

Trading on the LIFFE CONNECT® for Equities Trading Engine supporting continental Index Contracts and London Individual Equity Options and on the LIFFE CONNECT® for Financials Trading Engines was unaffected by this incident.

Customers and their clients were kept informed of developments via updates on the market status webpage (<http://www.liffe.com/marketstatus/>), and by e-mails.

Investigations are continuing into the root cause of this incident in order to prevent a recurrence.
