Members of the London Market should note the following Trading, Settlement and Back Office Considerations

Non-Target Settlement Days

Members should note that Thursday 1 May 2008 is a European public holiday and, as such, it is not a valid settlement day for euro payments.

Consequently, all euro-denominated variation and initial margin calls/payments relating to trading activity on 30 April 2008 will be called on 1 May 2008, in the normal manner, by LCH.Clearnet Ltd, but with a deferred value date of 2 May 2008. Euro-denominated variation and initial margin calls/payments relating to trading activity on 1 May 2008 will be called on 2 May 2008, in the normal manner, for value on 2 May 2008.

Back Office Considerations

As standardised and flexible Option Contracts based on UK stocks and the FTSE 100 Index will not be available for trading on 5 May, 26 May and 25 August 2008, premium payments due on these dates in respect of these Contracts will not be made until the following relevant market day. Notwithstanding that these and other Contracts will not be available for trading on these particular days, TRS will continue to be available for all Contracts. Therefore, members should continue to process their kerb trades for all Contracts in the normal way on these days. Members should also note that they are permitted to perform position maintenance (e.g. close-outs) for all Contracts on these days, notwithstanding the fact that some Contracts will not be available for trading. This may result in changes in open interest regardless of whether or not a Contract is available for trading.

On all UK public holidays on which the Exchange is open for business, the value date for any sterling-denominated initial and variation margin calls and payments will be deferred until the market day following the relevant UK public holiday.

Option Exercise

Options shall not be capable of being exercised on days on which such options are not available for trading/reporting. Any Exercise Notice given on such days in respect of such options shall be invalid.
