I - Delisting of shares of **GOLD FIELDS** from the Eurolist by Euronext Paris and from Euroclear France.

I - DELISTING OF **GOLD FIELDS** SHARES

Pursuant to Article L.421-4 of the Code monétaire et financier and Chapter 6, Book I - market Rules of Euronext, the Board of Euronext Paris decided that all **GOLD FIELDS** shares (ISIN code **XXXXXXXXXXXX** – trading symbol : **XX**), will be delisted from the Eurolist by Euronext Paris.

The Autorité des Marchés Financiers having notified to Euronext Paris its non-opposition to this de-listing, the de-listing from Euronext Paris will come into effect on **XX/XX/20XX**.

The **GOLD FIELDS** shares will notably remain listed on the **Johannesburg** Stock Exchange. **GOLD FIELDS** decided to implement an orderly procedure of withdrawal of its securities from the French market. The purpose of this notice is to describe the withdrawal procedure and is purely informative since Euronext Paris is not taking part at all in the sale facility procedure.

II - SALE FACILITY FOR **GOLD FIELDS** SHARES

In order to enable holders of **GOLD FIELDS** shares to sell their **GOLD FIELDS** shares, an orderly withdrawal procedure from the French market will be put in place, entailing continuation of the listing on Euronext Paris until **XX/XX/20XX** inclusive. It will be possible to voluntarily transfer in total or in part the **GOLD FIELDS** shares cost-free to **CACEIS** for sale on the **Johannesburg** Stock Exchange against distribution of an average

price as described below.

The Euroclear France affiliates should deliver the **GOLD FIELDS** shares presented to the sale facility to **CACEIS** at the latest on **XX/XX/20XX** for the session 1 and on **XX/XX/20XX** for the session 2. At the end of the session, the **GOLD FIELDS** shares provided to **CACEIS** will be sold on the **Johannesburg** Stock Exchange.

NB: Holders of **GOLD FIELDS** shares should note that the sale facility is entirely voluntary; they may prefer to retain their **GOLD FIELDS** shares under the terms and conditions stated by their account manager. Furthermore, holders of **GOLD FIELDS** shares wishing to sell their **GOLD FIELDS** shares may either wait until the last few days of the transfer offer before contributing them or trade them on Euronext Paris under the usual terms until the end of the trading session of **XX/XX/20XX**. The attention of the holders of **GOLD FIELDS** shares is also attracted to the fact that the sale on the **Johannesburg** Stock Exchange will be made by **CACEIS** for the account of the respective holders of **GOLD FIELDS** shares at the market price at the moment of the sale. This sale can be made in several times according to the liquidity on the **Johannesburg** Stock Exchange. The average price of the **GOLD FIELDS** shares sold for the account of the respective holders of **GOLD FIELDS** shares will be calculated by **CACEIS** and the proceeds, which the respective holders of **GOLD FIELDS** shares will receive in the same proportion to their stake in the sale, will be based on this average price.
