PROJECT: **Single Order Book**

Order book purge: securities which are traded but not listed on Euronext Amsterdam

In an info-flash dated 22 September 2008, clients were advised that for all dual or multi-listed securities within the Belgian, Dutch and French markets, all order books would be automatically purged on the night of **25 November 2008**.

In accordance with the usual process for the purging of order books, cancellation messages (SLE 0138) will be sent during the NSC-post trading session and received by members' workstations from 05.30 CET onwards. Clients are reminded that purged orders will **not be re-entered by Euronext**.

Please be advised that for the securities specified below, only the orders on the Euronext Amsterdam central order book (not official listed securities) will be cancelled, while the orders on the Euronext Paris central order book (official listed securities) will not be cancelled.
