### Executive Summary

This Info-Flash reminds members of the rules for the AEX-index.

3. Chapter 2 describes the rules on 'Calculation and publication of the AEX-index'. Item 2.5 states: The calculation of the level of the AEX-index starts when Euronext Amsterdam begins regular daytime trading in officially listed shares in accordance with the provisions of the Euronext Rule Book. If no price has been established for a constituent's share on the trading day concerned, the last known price established during regular daytime trading in officially listed shares on Euronext Amsterdam will be used.
4. Euronext announcements 99-120 published on 12 October 1999; 2002-081 published on 17 July 2002 and 2002-082 published on 19 July 2002 describe the settlement procedure for the AEX-index in the event of special market circumstances.
