CLOSING TIME FOR THE FTSE 100 INDEX FUTURES CONTRACT ON 27 AND 28 NOVEMBER 2008

Executive Summary:

This London Info-Flash informs Members of the closing time of the FTSE 100 Index Futures Contract on 27 and 28 November 2008.

1. On Thursday 27 November 2008, Thanksgiving Day, markets will be closed in the United States. As announced in London Notice No. 3026, issued on 2 May 2008, trading in the FTSE 100 Index Futures Contract will cease at 18:00 hours (London time) on that day, with pre-close at 17:58 hours.
2. On Friday 28 November 2008, the day after Thanksgiving Day, markets will close early in the United States. Trading in the FTSE 100 Index Futures Contract will therefore cease at 18:00 (London time) on that day, with pre-close at 17:58 hours.
3. All other session times shall remain unchanged.
4. In relation to the trading hours of other contracts on Thanksgiving Day, and on the day before and after it, Members should refer to www.nyx.com/liffeholidays.
