

## **ANNEX E, SPECIFIC TERMS OF USE**

TO THE GENERAL CONDITIONS (I) OF EURONEXT REGARDING THE SUPPLY AND USE OF EURONEXT MARKET INFORMATION  
(APPLICABLE FROM OCTOBER 2009)

### **1. NYSE Euronext Real-time Reference Prices**

**1.1** NYSE Euronext Real-time Reference Prices are supplied primarily for public display on Websites and TV Channels, defined as follows:

**Website:** One or more public internet uniform resource locators (URLs) with a single commercial brand or identity. Euronext reserves the right to determine whether any URL or group of URLs should be regarded as a separate Website for Fees purposes, taking into account the guidelines set out in this Annex E.

**TV Channel:** One or more broadcast or cable television channels with a single commercial brand or identity. Euronext reserves the right to determine whether any television content should be regarded as a separate TV Channel for Fees purposes, taking into account the guidelines set out in this Annex E.

### **1.2 Public Display of NYSE Euronext Real-time Reference Prices**

Client is allowed to display NYSE Euronext Real-time Reference Prices:

- a) Via Websites and TV Channels owned and operated by Client's Group,
- b) Via Websites and TV Channels owned and/or operated by Subscribers and hosted by Client's Group. For the purpose a website or TV Channel will normally be accepted as hosted by Client's Group, provided that:
  - i) the Client retains full technical and/or contractual control over NYSE Euronext Real-time Reference Prices displayed on Subscriber Websites and/or TV Channels,
  - ii) the Subscriber is only allowed to use NYSE Euronext Real-Time Reference Prices for display purposes on the Subscriber's Website and has no ability to use, process or redistribute this Information,
  - iii) the Client is identified as the provider of the displays of NYSE Euronext Real-time Prices on Subscriber Websites and/or TV Channels,

If a Subscriber Website or TV Channel does not meet the conditions specified above, for example if the Subscriber re-brands displays technically controlled by the Client's Group as the Subscriber's own products or services for use by third party Websites, the Subscriber shall normally be regarded as a Redistributor of NYSE Euronext Real-time

Reference Prices and shall be required to enter into a separate direct agreement with Euronext.

Clients may make NYSE Euronext Real-time Reference Prices available via Client's Group and hosted Subscriber Websites and/or TV Channels on condition that viewers of Information on those Websites and/or TV Channels:

- a) Are not charged any additional fee for access to the NYSE Euronext Real-time Reference Prices, and
- b) Are not allowed to redistribute the NYSE Euronext Real-time Reference Prices.

All displays of NYSE Euronext Real-time Reference Prices, including, for example, displays of default trade price data, intraday and multi-day charts, stock price retrieval facilities and stock tickers, must clearly identify NYSE Euronext as the source of the data.

Client will be required to report the names and number of all Client and Subscriber Websites and TV Channels on a monthly basis in accordance with Annex C. It is recommended that the Client takes a snap shot of all Client and Subscriber Websites and TV Channels on the 15<sup>th</sup> of each month. Before the second to last business day of each calendar month the Client will send to Euronext a report of the resulting inventory over the Reporting Period (as defined in article 1.1 of Annex C). The first report is to be produced at the second last business day of the first month after Client receives the NYSE Euronext Real-time Reference Prices service, with subsequent reports over each Reporting Period. Revised reports may be requested by Euronext on 30 days notice or submitted by Client, where the number of Websites or TV Stations is understood to vary substantially from the number previously reported.

### **1.3 Additional Uses of NYSE Euronext Real-time Reference Prices**

- i) Any other use of Real-time Reference Prices as defined above is subject to prior written agreement or approval by Euronext which may be subject to additional terms and conditions.
