GRADING AND WAREHOUSEKEEPING PROCEDURES IN RESPECT OF COCOA AND ROBUSTA COFFEE FUTURES CONTRACTS

Executive Summary

This Info-Flash informs Members that an updated version of the Grading and Warehousekeeping Procedures in respect of Cocoa and Robusta Coffee Futures Contracts is available on the Liffe website and in the London Market Handbook.

1. London Notice No. 2986, issued on 27 December 2007, informed Members of the availability for trading of a revised Robusta Coffee Futures Contract (Exchange Contract No. 409) with effect from 14 January 2008 and set out transitional arrangements, together with changes to the Grading and Warehousekeeping Procedures in respect of Cocoa and Robusta Coffee Futures Contracts (“G&WPs”).
2. This Info-Flash informs Members that, following completion of the transitional arrangements, a consolidated version of the G&WPs will be made available on the Liffe website (www.nyx.com/liffe) and in the London Market Handbook (www.nyx.com/londonhandbook) on and from Monday 2 February 2009.
