An implementation date for the interoperable clearing solution will be announced shortly.

Members wishing to clear NYSE Arca Europe trades via LCH.Clearnet Ltd. are encouraged to participate in member testing that is scheduled to commence on Monday, 24 August 2009 for a two-week period.
