### UK INDIVIDUAL EQUITY OPTIONS AND FTSE 100 INDEX OPTIONS

### APPOINTMENT OF A PRIMARY MARKET MAKER

#### Executive Summary

This Info-Flash informs Members of the appointment of an additional Primary Market Maker for FTSE 100 Index Options (“FTSE Options”).

1. London Info-Flash No. LO09/33, issued on 16 September 2009, invited Members to apply for vacant Primary Market Maker (“PMM”) and Primary Liquidity Provider (“PLP”) positions for UK Individual Equity Options and FTSE Options.
2. **Subject to the completion of a legal agreement**, this Info-Flash confirms the appointment of an additional PMM in FTSE Options for the remainder of the current Scheme. Such appointment is subject to standard contractual terms (e.g. in respect of early termination).
3. An updated list of the classes within the current Schemes, and the PMMs and PLPs appointed for each Individual Equity Option and FTSE Options, forms the Attachment to this Info-Flash.
4. The current Schemes will remain in place until the close of business on 30 June 2010.
