NYSE Arca Europe trading cycle to include a closing call phase – a reminder

Following the Info-Flash of 15 January 2010, NYSE Arca Europe would like to remind customers that a new trading cycle including a closing call phase will come into effect on 15 February 2010 in the production environment.

As a reminder, in the scope of the 2010 functional enhancement programme, NYSE Arca Europe is pleased to announce the implementation of a **closing call phase from 17:30 to 17:45 CET following the close of the markets**.

Thanks to this enhancement, clients will now be able to cancel orders after market closure.

Please note that **the closing call phase will not be followed by an auction**.

This evolution took effect in the External User Acceptance (EUA) test environment:

- on Monday, 18 January 2010 for the trading groups 1A, 1J, 1G and 1Z,
- and on Thursday, 11 February 2010 for all trading groups.
