Please note the following updates to SWIFT Release 2023.

Scope of SWIFT Release 2023

SWIFT Release 2023 will make some changes to MT564 and MT566 messages sent by Euronext Securities Milan to participants that subscribe to SWIFT reporting.

In detail, MT564 messages will change the following TAGs:

- In sequence D CADETL (Corporate Action Details), option C will be replaced by option A for TAG 98 RDTE (Record Date) for CAEV DVCA / INTR / CONV / EXWA / REDM / PCAL / PRED / DECR / CAPD / CAPG / MRGR / BONU / SOFF / DVSE / SPLF / DSCL / RHDI / EXRI / DVOP / DRIP / DVSC;
- In sequence D CADETL (Corporate Action Details), option C will be replaced by option A for the 98 GUPA (Guaranteed Participation Date) for the CAEV CONV / EXWA / REDM / BONU / EXRI / DVOP.

MT566 messages will change the following TAGs:

- In the C CADETL (Corporate Action Details), option C will be replaced by option A for TAG 98 RDTE (Record Date) for CAEV DVCA / INTR / CONV / EXWA / REDM / PCAL / PRED / DECR / CAPD / CAPG / MRGR / BONU / SOFF / DVSE / SPLF / DSCL / RHDI / EXRI / DVOP / DRIP / DVSC;
- In sequence D CACONF (Corporate Action Confirmation), the qualifiers EXPI (Expiry Date/Time), RDDT (Response Deadline Date/Time), MKDT (Response Deadline Date/Time) on the CAEVs EXWA / BONU / EXRI / DVOP / DRIP / DVSC / RHDI / SOFF / DVSE will be deleted.

In any case, Euronext Securities Milan will proceed with the release into production of the reported changes on the understanding that no impediments have been detected.
