Results of the March 2019 Review:

PSI 20®

No changes in the composition of the index.

The compiler retains the right to change the published selection, for instance in case of a removal due to a take-over, till the publication of the final data after close of Wednesday 13 March 2018. All events happening after that date will not lead to a replacement of the selected company that possibly needs to be removed from the final selection.

Review PSI 20®

The PSI20 index is reviewed quarterly in June, September and December. The full annual review is in March. The quarterly reviews serve to replace removed constituents and to facilitate inclusion of recently listed companies.
