## FEES RELATED TO REVIEW OF ADMISSION DOCUMENTS, LISTING AND REGISTRATION OF BONDS AND COMMERCIAL PAPERS ON OSLO BØRS AND NORDIC ABM

The following fees apply to review of admission documents not encompassed by the Prospectus Regulations and listing and registration of bonds and commercial papers on Oslo Børs or Nordic ABM.

- D) Ordinary senior bonds issued by a bank, ordinary covered bonds and other particular standardized types of bond at the discretion of Oslo Børs.
- E) Bonds of types other than those mentioned in item E.
- F) The fee is set at twice the registration fee for "other bonds". The fee will not apply to bonds secured by collateral where a third-party valuation is provided which, in the opinion of Oslo Børs, provides sufficient information on the collateral. The fee will not apply to bonds that are guaranteed by the state or by a municipality or county authority.
- G) The fee is set at three times the registration fee for "other bonds". The fee will not apply to bonds secured by collateral where a third-party valuation is provided which, in the opinion of Oslo Børs, provides sufficient information on the collateral. The fee will not apply to bonds that are guaranteed by the state or by a municipality or county authority.
- H) The fee becomes payable when an admission document is submitted to Oslo Børs for inspection, even if the inspection subsequently is not, or cannot be, completed.
- I) For issuers specifically applying to list the extension, an additional fee of NOK 10,000 is incurred.
