INTRODUCTION

Clients of Euronext Securities Milan (ES-MIL) are allowed to move securities between their ES-MIL's account and an account on a different CSD through the links that ES-MIL has established with several foreign CSDs, in T2S and outside T2S.

While T2S helped to standardize cross csd instructions, there are still several cases, especially on external transactions, which may require the usage of specific settlement formats.

In addition, ES-MIL's Clients, also need to provide their counterparties with their correct SSI (Securities Settlement Instructions) in order to settle a transaction.

This document is designed with the aim to provide Client's with a useful tool that summarizes all the information needed to execute a transfer from/to ES-MIL, versus another CSD, in a single page.

This Document contains:

- Information on how to identify the CSD where ES-MIL holds a foreign security
- Templates for allowed external settlement instructions in Swift 15022 and XTRM
- Templates for T2S allowed cross csd settlement instructions in Swift 15022 and XTRM
- Settlement restrictions
- SSI to be shared with Counterparties to help them matching ES-MIL's Clients instructions where applicable

We aim to keep this Document updated reflecting the latest changes in the market.

ES-MIL is not responsible for the correctness of your settlement instruction, the counterparty will always have to provide you with their most updated SSI, we kindly ask you to get in touch with ES-MIL in case of doubts.

1. Settlement overview

Securities can be settled by ES-MIL's Clients against counterparties:

- In ES-MIL : such transactions are defined **Intra CSD** settlement

ES-MIL's Client will instruct against a counterparty in ES-MIL and the counterparty will do the same

- In another T2S CSD: such transactions are defined **Cross CSD** settlement

ES-MIL's Client will instruct against a counterparty's CSD different from ES-MIL but participating in T2S and the counterparty will instruct from the other CSD against ES-MIL

- In another CSD outside T2S: such transactions are defined **External CSD** settlement

ES-MIL's Client will instruct against a counterparty's CSD based on the links between ES-MIL and the other CSD outside T2S and the counterparty will instruct from the other CSD against ES-MIL

1.1.1 How to use this Document and further instructions

The correct page for retrieving the format for your instruction can be found in the **Table of Contents** of this document, following the next steps:

1. Identify **where ES-MIL holds the security** and select the correspondent chapter in the Table of Contents of this Document

This information can be found in MTX → Lists → MT23 List of Financial Instruments → Search ISIN

When the value in the column **issuer/Investor** is "**Investor**" then the value in the **Issuer Code** column identifies **the Issuer CSD**. If the value is "**Issuer**" then the **Issuer CSD is ES-MIL. This is where ES-MIL holds the mentioned security.**

The same value can be found in the Table of Contents of this document and is **used to identify the correct chapter.**

As reported in Euronext Clearing Migration FAQ, Operational Notice 22/2023 published on July 17th and Operational Notice 28/2023, certain Financial Instruments have been transferred from the home issuer CSD to the technical issuer ESES CSDs. With Operational Notice 07/2024 the Austrian Bonds have been moved back to OeKB as Issuer CSD therefore chapter 9 of this guide can be used for all indicated counterparty's CSD, the following sentence does not apply to Austrian Bonds. Clients should remind that those securities can be transferred, according to the Issuer CSD chapter of reference in this Guide, as Intra or Cross CSD between ESMIL and the Technical issuer CSD.

The gateway has been updated on 31st October 2025 in order to reflect the new denomination of Cleastream Banking Frankfurt in Cleastream Europe.

2. Determine the **CSD of your counterparty** and **select the appropriate Issuer CSD/Counterparty combination from the Table of Contents** of this Document

This information is based on your counterparty's SSI and will be used to find the correct settlement combination in the Table of Contents of this document.

PLEASE NOTE:

- For each settlement combination we have also included the SSI that you will share with your counterparty
- Each page will also specify whether the transaction can be executed only FOP or if the market executes DUMP trades
- Please always use 11 digits bic codes when instructing trades
- Please note that Party 2 in T2S is optional and if populated in one of the two instructions involved in a securities transaction then it becomes a matching criteria and has to be quoted on both instructions
- Delivery Swift instructions should always contain also the field DEAG (15022 or corresponding MT20022 field)
- Receive Swift instructions should always contain also the field REAG (15022 or corresponding MT20022 field)
- XTRM Cross-csd and External instructions should always be instructed using the BIC code in the field "Trading member code"
- External instructions can not be instructed with HOLD/RELEASE indicators
- If a client will incorrectly instruct a security not available in the MT23, please be aware that any possible fail and related CSDR penalties will not be cancel and they will be computed as current procedure described
- XTRM Cross-csd should always be instructed with a "Ctrp Settl. Account" filled in where "Cod. Ctrp" is filled in with a no default BIC
- Cross-csd and External settlement instruction when searched, will have the CTRP cod. field populated by the internal code (SIA/CED) instead of the BIC used in the input function
- External Settlement is subject to CoSD rule in the following case: prepositioning (DFOP and DVP) and prefunding (RVP). More information could be find in the Istruzioni al Servizio di Liquidazione
