1. PURPOSE OF THIS DECLARATION

Euronext Amsterdam, Euronext Brussels, Euronext Dublin, Euronext Lisbon and Euronext Paris are Regulated Markets within the meaning of Union Law. Each of these Euronext regulated markets is, if not identified by name, referred to as the “Relevant Euronext Regulated Market”. The Relevant Euronext Regulated Markets are respectively organised by Euronext Amsterdam N.V., Euronext Brussels S.A./N.V., The Irish Stock Exchange plc trading as Euronext Dublin, Euronext Lisbon – Sociedade Gestora de Mercados Regulamentados, S.A., Euronext Paris S.A. Each of these market undertakings is, if not identified by name, hereunder referred to as the “Relevant Euronext Market Undertaking(s)”.

Capitalised terms used but not otherwise defined herein shall have the meaning ascribed to such terms in the aforementioned Rules.

This declaration reiterates undertakings and information which must be provided to the Relevant Euronext Regulated Market Undertaking in connection with the first admission to trading of Securities on the Regulated Market of Euronext as set out in the Rules (the “Admission”) and Euronext Notice No 6-01.

The information and provisions contained in this declaration shall not detract from the enforcement of the Rules, which take precedence in the event of any conflict with this declaration. Furthermore, this declaration does not infringe the Regulated Market of Euronext’s right to make the Admission subject to specific conditions or any additional information or documentation, not specifically referred to in this declaration, it may deem appropriate. This declaration and the information and provisions it contains are without prejudice to the applicable National Regulations and to the competences of the relevant Competent Authority.

This declaration should be submitted electronically to the Relevant Euronext Market Undertaking by uploading the signed version on the *MyEuronext - Equity Admission App*.

This declaration must be submitted together with the relevant application form for the Admission.

In connection with the Admission of the Issuer on the regulated markets operated by Euronext, we hereby certify that:

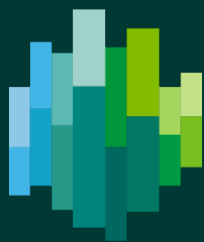
- (i) we will assist the Issuer with the application for admission to listing of the relevant securities as set out in the Rules;
