# MOSELLE RIVER DELIVERY PORTS UNAVAILABLE FOR RAPESEED EXPIRY IN FEBRUARY 2025

To the attention of:	<b>Clearing Members</b>

Topic:	<b>Physical Deliveries for the Rapeseed Futures Contract</b>

Euronext Clearing notifies its clients that, due to an accident on the Moselle-Saar-Lahn waterway - where a cargo ship collided with the lock gates, causing significant damage - the delivery points located along the Moselle River (Belleville, Frouard and Metz) will be unavailable as delivery ports for the February 2025 expiry of MATIF rapeseed futures contracts (ECO G5, FREN05899108) until further notice.

For the next expiry (May 2025), there is still some uncertainty regarding the availability of the French delivery ports. Euronext Clearing will provide further updates.

Below is a summary of the status of the delivery points for the above-mentioned expiry:
