Dear Client,

We wish to announce that the upcoming 6.0 release of T2S will be available in the external test environment (UTEST) on 2 May 2022. The 6.0 release of T2S consists of 15 change requests and the resolution of 20 defects, 2 of which was identified by Euronext Securities Milan or by its participants. The 15 change requests include CR-722, which implements the new non-repudiation mechanism based on the Ascertia Go-Sign Desktop software, and CR-701, which implements the new ESMIG portal for access to target platforms.

## **Test plan**

Participants that use Euronext Securities Milan systems may conduct external tests as of Tuesday 3 May (to allow for completion of the necessary technical configuration), until Friday 1 July 2022.

DCPs are invited to re-test all defects and change requests applicable to their operating model, indicating in the relevant "R6.0 PBI and CRs content incl declaration to test v1.0.xls" form whether they wish to proceed with re-testing, and reporting the status of verifications on a weekly basis to the address <u>MT-T2S-test@euronext.com</u>.

In accordance with the plan produced by the European Central Bank, DCPs are asked to send feedback on the final outcome of the tests of CRs and PBIs by 10:00 hours on 13 June 2022, to

the address <u>MT-T2S-test@euronext.com</u>. This feedback will be included in the report sent to the T2S decision-making bodies on the same day.

Testing may continue after that date until 1 July 2022. Any additional evidence will be reported to the said decision-making bodies on an ongoing basis for the purpose of verifying the stability of the release.

The 6.0 release of T2S will be launched into production on 2 July, effective as of 4 July 2022.

## Plan to release the software in the UTEST environment

The 6.0 release will take place according to "option 2" as defined in the MOP.

In this mode, T2S will close the A2A and U2A communication channels around 14:50 hours on Wednesday 27 April 2022. All messages sent after this time will not be reprocessed in T2S due to the implementation of the new ESMIG communication portal.

The reopening of the A2A channel **on the new T2S ESMIG portal** is scheduled for 16:50 on Friday 29 April 2022. As of that moment, clients will once again be able to send messages to T2S.

The availability of Euronext Securities Milan services will be aligned with the declared schedule for T2S.

The PTTS SOMT team will announce by email the completion of the times and stages as set out in the release schedule.
