Dear clients,

As of **1 September 2026**, Euronext Securities will introduce changes to our settlement fee schedule.

Our new fee structure is designed to support your growth in key European markets, helping you optimise settlement costs and enhance operational efficiency.

Transparency and clarity are essential for our clients and for all market participants, which is why we are committed a straightforward fee structure.

Currently, the settlement instruction fee in Euronext Securities Milan is ≤ 0.23 for clients with a direct connection to T2S (DCP), and ≤ 0.35 for clients with an indirect connection (ICP).

As of 1 September 2026, we will introduce the following changes to settlement instruction fees in Euronext Securities Milan:

- For all other securities, the fee will remain at €0.35 per settlement instruction
