Dear Clients,

We would like to inform you that some amendments have been made to the **Terms & Conditions relating to the MyEuronext Access Form**.

Please note that, if you have already submitted the MyEuronext Access Form, the previously signed form remains valid, and you will therefore not be required to complete and resubmit the form.

In particular, changes have been made to the following section – **“Schedule 2: Administrators Appointed by the User Company”**, allowing User Companies to amend the information provided in this section, including to add new Admin Users or update existing ones.

Furthermore, amendments have been made to the following section – **“Schedule 3: Service Levels”**. The Service Levels introduce specific service objectives relating to the availability and support of the platform, which is accessible 24/7, with operational support available Monday to Friday (09:00–18:00 CET) and out-of-hours on-call support for Sev 1 incidents.

The form must be signed by the authorized signatories of the relevant User Company.
