Account Operator Service and SWIFT messaging rationalisation - Test Plan

Dear Client,

We are pleased to announce that Monte Titoli has completed its development of new Account Operator functionalities through the SWIFT channel and has synergistically taken the opportunity to rationalise SWIFT 15022 custody services messaging to bring it into line with client requirements, established practice and international standards.

To complete this adaptation, the CLIMP portal for the configuration of accounts and services has also been re-engineered and optimised to provide clients with greater flexibility and operational efficiency through the implementation of a new 'Op. Mandates & Swift Config.' menu for the set-up of all SWIFT messaging, whether used directly or delegated to an Operator.

Accordingly, as provided in the 2020 road map, from 31 August next the new service and functionalities will be available to all participants using the SWIFT transmission channel for the launch of the external test phase.

Test plan

The tests have the following objectives:

- verification of the new interface for the configuration of SWIFT messaging and mandates relating to the SWIFT Account Operator functions;
- verification of SWIFT messages modified to conform to client requirements, established practice and international standards;
- non-regression verification for all the above SWIFT messaging.

A supplement to the Test Plan will be issued by 7 August 2020, through a dedicated ON, setting out the details of each event prepared by Monte Titoli for individual test cases (cf. Appendix 1 Test Plan).

Test and release dates

The tests will take place between 31 August and 25 September 2020 in the Monte Titoli test environment named “Pre-production”, connected to the T2S test environment named “UTEST”.

If no contraindications are documented (to be sent to the address MT-test-custody@lseg.com by and not later than 29 September 2020), the ‘Go Live’ in the production environment is scheduled for 5 October 2020.

Monte Titoli will consider the absence of feedback as tacit consent to the introduction of the new functionalities into production.
