DATA CENTER

Market View

It enables you to jump quickly to not only your order book data, but also your watchlists, portfolios, market indicators, brokers' market share, MTF market share, analyst opinions and liquidity provider data.

Price Chart

Downloadable price history since 1999 for all companies listed on Euronext markets, stock charts (comparisons with indices, sectors or other companies).

Order Book

Your Order Book can be viewed as a Chart or in Data mode. It allows you to see the top 10 bid and ask limit prices for your stock in real-time.

Watchlists

Build your own list and follow prices and volumes over different periods, on your stock and your competitors at any time. You can select stocks from the following exchanges: Euronext, London Stock Exchange, Deutsche Börse.

Brokers Market Share

Follow the key players in your stock every day. Market share and trading volumes for the period by the top ten brokers (buying and selling). Data, calculated on the basis of volumes traded in the central order book and off order book transactions, can be downloaded in Excel daily, weekly and monthly.

Liquidity Provider

The liquidity provider panel allows you to view and sort the monthly performance of your liquidity provider by presence rate, average capital amount and spread.

MTF Market Share

This feature shows you the daily volume distribution of shares traded on Euronext compared to the main MTFs (BATS, Chi-X, Turquoise and Equiduct). You can view your MTF Market Share as a Chart or in Data mode.

Real-time indices, information about companies listed on Euronext markets in Europe (downloadable profile and share prices), multi-criteria searches (sector, market capitalisation etc).

The Monthly Statistics toolbar lets you select a complete set of data profiles for any given month. First, select the month you wish to review, and then choose from any of the tabs above.

Don't let anyone beat you to the information! Designed to help you follow your stock in real-time, the Web Alerts service is a user-friendly online application that keeps you informed of your share price by email on your PC or smartphone.
