# OPTIQ PHASE 3 DERIVATIVES – REMINDER NEXT EUA (P-EUA) ENVIRONMENT CLOSED FOR UPGRADE

#### **Summary**

Euronext would like to remind customers that Derivatives Next EUA (p-EUA) environment will be temporarily closed for three weeks starting **3 June 2019**. During this period customers are advised to use Current EUA (v-EUA) for testing.

### Reminder of temporary closure of Next EUA

Following the Optiq notice of <u>7 May 2019</u>, Euronext would like to remind customers that the Derivatives Next EUA (p-EUA) environment will be closed for three weeks starting **3 June 2019**. During this period the platform will migrate from UTP-D to Optiq. Next EUA will re-open during the **week of 24 June 2019** with Optiq OE/ME.

Note that this temporary closure on Next EUA (p-EUA) environment only concerns Derivatives segments, and Cash segments are unaffected. Front-to-end testing with LCH will not be available for Derivatives during the temporary closure.

OEG connectivity (logical accesses) details will be made available to clients during the closure, two weeks prior to the opening of Next EUA. Customers are recommended to perform telnet on EUA as per the *Optiq OEG Connectivity Specifications* and *Telnet* document available in the <u>IT DOCUMENTATION</u> section of the Optiq Project webpage.
