

EURONEXT CAC 40 GOVERNANCE INDEX

In partnership with vigeoeiris

The CAC 40® Governance index, designed in partnership with Vigeo Eiris, shows the performance of the CAC 40 constituents weighted on the basis of their governance score, which includes the 40 largest and most actively traded shares listed on Euronext Paris.

Corporate governance structure identifies the distribution of rights and responsibilities among the different participants in the organization and lays down the rules and procedures for decision-making.

The CAC 40 Governance index is based on Vigeo Eiris' rating methodology.

Vigeo Eiris is an independent global provider of environmental, social and governance (ESG) research and services to investors and public and private corporates.

Vigeo Eiris assesses and rates the performances of companies on their corporate governance responsibility according to the Equitics® Responsible Corporate Governance methodology. Its score is built with an assessment framework structured by four underlying criteria:

- Responsible Board Practice and Organisation
- Audit and Internal Controls
- Shareholder's Rights
- Responsible Executive Remuneration.

Benefits of good corporate governance (according to the OECD)

Good corporate governance creates value in the long term and impacts share value thanks to:

- Improved top-level decision-making processes
- Better environment control
- Reduction in firms' cost of capital

Index Methodology

The weighting of each company expected to be included in the underlying index at the review date is based on the **Equitics Corporate Governance score** of the company:

- Companies are ranked in four groups of ten according to their Corporate Governance score
- Companies in each group are equally weighted
- Quarterly periodical review and rebalancing of the index, like the CAC 40 index
- The new weights are based on this ranking and are calculated as follows:

1 to 10	40%	4%
11 to 20	30%	3%
21 to 30	20%	2%

CAC 40 Governance is the first responsible corporate governance index launched by Euronext in partnership with Vigeo Eiris. The index is launched in three versions, the Price Version mentioned and the CAC 40 Governance NR (net return) and CAC 40 Governance GR (gross return).
