The composition of the Amsterdam Midkap-index (AMX) from 1995

The Amsterdam Midkap-index was compiled by the AEX-Optiebeurs in 1995. Over the years, the composition of this stock index has been changed a number of times.

The value of the Amsterdam Midkap-index is calculated by multiplying the price of each stock by its weighting factor. These amounts are then cumulated and divided by one hundred.
