In anticipation of the Dress Rehearsal as of **7 April**, all Fixed Income members will receive their logins and ports for the Production environment on the week of **25 March**. Customers are invited to ensure they have taken the appropriate actions in terms of network and security to be able to connect to Production with their new logical accesses on **7 April**.

As a reminder, the P-EUA platform is closed for maintenance every **Wednesday** until 13:00 CET, and the V-EUA platform is closed for maintenance every **Tuesday** until 13:00 CET.
