OPTIQ PHASE 2: NEW OEG & SBE TEMPLATES VERSION AVAILABLE IN V-EUA

Summary

Euronext informs clients that OEG SBE and MDG SBE templates version 103 are now available in V-EUA. The only change in the template is the version provided, and matches what Optiq replies to clients. Functionally and structurally no changes are included in this update.

SBE TEMPLATES VERSION 103

Today the V-EUA environment was updated and is now compatible with a new version 103 of OEG SBE and MDG SBE templates. Both templates are activated as of today, **Thursday 17 May**. They are available on the Euronext website and on EFS.

CHANGE IN THE NEW TEMPLATE

For internal technical maintenance purposes Euronext requires to provide a new version of the Optiq SBE templates.

The only change in the template is the version provided, and matches what Optiq replies to clients. Functionally and structurally no changes are included in this update.

Clients are reminded that SBE templates are backward compatible, and a higher version of SBE could be replied by Optiq, and client applications should be able to manage such difference in versions without an impact.
