Markets will close on the evening of Friday 7 July 2017 and open on Monday 10 July 2017 as usual, without taking the activity of Saturday 8 July 2017 into account. Customers are responsible for purging all market data and order entry data sent and received during any Saturday test.

## 1. SCOPE OF THE TEST

---

In Scope:

- MDG Cash & Derivatives
- XDP-D(erivatives)
- Order Entry Derivatives

It is mandatory for customers to participate and successfully complete testing during the dress rehearsal.

Customers who complete the technical and functional testing successfully for Derivatives are not required to participate in another Dress Rehearsal.

Please find below details relevant to the Optiq Market Data Gateway (MDG) Derivatives Dress Rehearsal tests for Saturday 8 July 2017.

**From 10:00 CEST until 13.00 CEST, customers that are connected to Optiq MDG Cash might notice Market Data being broadcasted:**

- Euronext plans to perform multiple internal tests on Cash MDG to ensure a smooth transition for Monday the 10th of July when MDG will be the primary source for Cash Market Data.

**From 13:00 CEST until 16.30 CEST, customers are requested to:**

- Test their connectivity to the Derivatives MDG production channels for those that have not tested connectivity before the start of the dress rehearsals
- Log on through their order entry connections Derivatives engines: Options and Futures, Currency, Commodities.
- Check the market data broadcast via multicast by connecting their application/feed handler to:
  - XDP Derivatives - Real time, Refresh and Retransmission services
  - Optiq Derivatives Market Data services - Euronext File Services, Real time, Snapshot
  - Customers who connect to Cash MDG might see market data broadcasts from 10:00 am to 15:00 pm. This data is the result of internal tests Euronext plans to perform.

## 2. OUT OF SCOPE

---

- AtomX
- RiskGuard
- Settlement on Derivatives
- Post-trade systems: trades will not be integrated into the clearing system and no clearing members will be involved in this test.

## 4. MAIN PRINCIPLES OF THE TEST

---

Euronext will start a pre-opening trading session. Customers will be notified to connect to the platform via the [Market Status webpage](#).

Members should then be able to see Euronext Market Data in dual run:

- Euronext Derivatives Market Data going over the current Production system: XDP
- Euronext Derivatives Market Data going over the new Pre Production system: Optiq MDG : Step1

As soon as Euronext considers that the Derivatives markets are ready to be fully operational, a continuous trading session will be set up on the Universal Trading Platform. Customers are invited to make sure that their internal systems and access means are correctly synchronised with Euronext central systems.

Euronext would like to make this test as realistic as possible in order to draw the most relevant and useful conclusions, and therefore encourages customers to participate actively by sending orders.

## 5. TRADING DATES DETAILS

---

The trading date used for the purposes of the test will be Saturday 8 July 2017. The order book situations will be those of Monday 10 July 2017 before the start of the pre-opening session, i.e. after the corporate events of the evening of Friday 7 July 2017.

Euronext invites members to enter orders as they do in the Production environment.

MDG Standing data files for Derivatives Market will be made available on Saturday 8 July 2017 with the business date of Monday 10 July 2017. Please make sure you do not have any security in place that would prevent to process them.

MDG standing data files for Derivatives will be different from the known production database with the particularities that:

- They will be based on Thursday 6 July evening state.
- Strategies standing data will be included

### 5.1 PRE-REQUISITES FOR TAKING PART IN THE DRESS REHEARSAL

#### 1) Market data contract signed

Customers will be authorised to access Euronext production markets only if they have signed a Euronext Market Data agreement.

#### 2) Connectivity to production confirmed

As of 29 April 2017, authorised customers can see “Start Of Day” messages going over Euronext production Optiq Market Data channel (as defined in the following document: [Connectivity test action plan Optiq Production V1.0](#)).

Customers must have a Euronext File Services (EFS) account to access the Pre-Production Optiq Euronext File Services. They can request their account by contacting Customer Access Services (CAS):

## 7. IMPORTANT REMINDERS

---

During the test, Euronext will not be able to broadcast the Standing data messages over Optiq Market Data twice. Customers who have missed the broadcast of the referential data are requested to use the Optiq MDG Standing Data files available on the [EFS](#).

**Communication about the timeframe of the Production Optiq MDG implementation on the Euronext Derivatives Markets will follow in due course.**

## 8. ROLL-BACK FOR CUSTOMERS' INTERNAL SYSTEMS

---

Upon completion of the Dress Rehearsal, members must restore/rollback their internal Production systems to the state of Friday 7 July 2017 evening after corporate events. It is very important that members do NOT synchronise their order book with data from Saturday 8 July 2017.

The Saturday 8 July 2017 session will not be taken into account in the Live/Production environment which will start on Monday 10 July 2017 as usual. Customers are requested to ensure their readiness for the next trading day's activities following any Saturday test.

**Members are responsible for purging all market data and order entry data sent and received during any Saturday test.**
